37.1 Confirmation of the Minutes of the 36th Meeting of the Governing Board held on Friday, 7th December, 2018 at INFLIBNET Centre, Gandhinagar

The Minutes of the 36th Meeting of the Governing Board of INFLIBNET Centre held on Friday, 7th December, 2018 at INFLIBNET Centre, Gandhinagar were confirmed as circulated, since no comments were received from the Members.

37.2 Report on Action Taken and Progress made since 36th Meeting of the Governing Board held on 7th December, 2018 at INFLIBNET Centre

Prof J P Singh Joorel presented a report on action taken on the various decisions made during the 36th Meeting of the Governing Board. The important actions taken were presented to the Members as per the following details:

- 2.1 **Minutes of the 36th Meeting of the Governing Board**, duly approved by the Chairman, GB were circulated to the Members. No comment received from the Members.
- 2.2 Actions taken and progress made since 35th Meeting of the Governing Board held on 24th July 2018: Already reported in the 36th Meeting of the Governing Board held on 7 Dec 2018.
- 2.3 New Projects at the INFLIBNET Centre: New projects taken by the Centre after 36th Meeting of the Governing Board are being under execution. The details of new projects taken by the Centre is given at item No. 3.
- 2.4 **Projects in Pipeline:** The projects including Access to Plagiarism Detection Software to all Universities/HEIs, Development of Web Portal for Central Sector Scheme Pandit Madan Mohan Malviya National Mission on Teachers and Teaching (PMMMNMTT) and e-Governance are under process.
- 2.5& 6 Arbitration Case: The Director presented, before the Governing Board, the details of amount deducted by the Centre, amount claimed by the civil contractors, amount awarded to contractors by the Arbitrator and amount spent in litigations. After detailed discussions and deliberations, the Governing Board unanimously resolved to constitute a Committee of the following Members to negotiate with the civil contractors for out of the Court settlement and submit progress report to the Governing Board. Director was advised to call a special meeting of Governing Board on this issue after the negotiations/settlement with contractors by the Committee.

- 2.7 **The AMC of Institute Building & hiring of Sr Consultant:** The hiring of services of Sr. Consultant/JE through Man Power agency is in process meanwhile CPWD was requested by the Centre to carry out the maintenance of the building. However, CPWD officials informed during their visit to the Centre, that CPWD can take the responsibility of the maintenance of the building only after the arbitration proceedings over.
- 2.8 **Promotion Policy for the Scientists and Staff of INFLIBNET Centre:** As per the decision taken in the 36th Meeting of the Governing Board, Joint Secretary (Estt.) DoPT was requested to nominate a suitable officer vide letter dated 18th Jan 2019 and reminded vide letter dated 12th Feb 2019. However, during telephonic discussion, between Director and J S (Estt) DoPT, the concerned officer informed that, DoPT generally doesn't nominate any official for such purpose.

The Members of the GB unanimously opined that to attract, retain and keep motivated and talented employees in an Organisation, it is very essential to have a promotion policy for the staff.

Keeping in view the career prospects and growth of the Centre, the Governing Board after a detailed discussion and deliberation on the promotions issue, unanimously resolved for strict adherence of the promotion policy that already exists in the Bye-laws of the Centre under Clause 4. The Centre was also advised for early implementation of the promotion policy.

- 2.9. Incentives on Acquiring PhD degree: A Committee has been constituted.
- 2.10 Recognition of Aashka Multispecialty Hospital under the Approved Health Scheme for Medical Treatment to the Staff and Dependents: INFLIBNET Centre has signed the MoU with Aashka Multispecialty Hospital, Gandhinagar on 22.02.2019 for Medical Treatment to eligible Staff and Dependents of the Centre.

37.3 New Projects/Initiatives under taken by the Centre

Prof J P Singh Joorel, Director, INFLIBNET Centre presented a brief to the Governing Board about the details on the progress on all the projects and activities undertaken by the Centre. The Governing Board was informed that the all the projects undertaken by the Centre are of national importance and are being completed in a time bound manner. Director also informed about the "Excellence Award 2019" awarded to the Centre as an "Emerging Institute Promoting Government Digital Initiatives" during 12th ASSOCHAM National Education Summit presented by Union Minister Shri Suresh Prabhu Minister of Commerce & Industry and Civil Aviation.

All the Members of the Governing Board appreciated and praised the efforts taken by the Centre in the field of various initiatives towards digitization in India.

The Members also took a note of the new projects taken-up by the Centre. The new projects are: (i) Indian Research Information Network System ii) Scheme for Higher Education Youth for Apprenticeship and Skills (SHREYAS) (iii) Providing Technological Solutions for the College and University Libraries in North Eastern Region of India (iv) Anti Plagiarism Detection Software (PDS) for all Universities and Higher Education Institutes (v) Development of SOUL 3.0 (vi) Web applications for "NCTE Accreditation Management System (NAMS)" (vii) Digital Education Solutions for IGNOU (viii) Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNMTT) (ix) e-Governance at UGC (x) Human Resource Development and Consultancy.

In regard of Human Resource Development and Consultancy, Chairman GB advised that Centre may increase the number of training programs so that more and more teachers and educational fraternity can be trained.

37.4 Confirmation of the decision taken by Chairman, GB

The Governing Board approved the decision of the Chairman, GB to file appeal in arbitration under section 34 instead of 33 of Arbitration and conciliation Act 1996 as per the legal opinion of the Asstt. Solicitor General of India.

37.5 Uploading of the Minutes of the Governing Council, Governing Board and Finance Committee of the INFLIBNET Centre on the website of the Centre

The Governing Board approved the proposal of uploading the Minutes of Governing Council, Governing Board etc., on its website to have more transparency in the decision making.

37.6 Hiring of Accounts Consultant on Contract Basis

The Director briefed the Governing Board about hiring of Consultants/Sr Consultant one each for Administration and Scientific activities that was approved by the Governing Board in its 22nd Meeting held on 4th December 2010. Accordingly one

Accounts Consultant was hired w. e. f. July 2011 who continued till August 2017. However, the Centre requires the continuation of services of the Consultants for smooth handling of the work.

The Governing Board approved the hiring of Consultants on Contract basis as per the past practice.


37.7 Revival of Already sanctioned/Vacant Posts

The Members of the GB were informed by the Director that the Centre has few vacant posts that were sanctioned by the UGC but could not be filed due to one or another reason, however these posts are essentially required for the smooth functioning of the Director's secretariat, administrative sections including setting up SC/ST cell at the Centre. The Finance Committee in its meeting held on 15th March 2019 recommended the revival of the posts.

After detailed discussions and deliberations, the Members endorsed the decision of the Finance Committee to revive the vacant positions, given below:

37.8 Creation of Scientific/Technical Post and Support area

The Director briefed the Governing Board about the various activities of the Centre and other projects entrusted by the UGC, MHRD and other autonomous bodies of the Central Govt. The Centre has the support of only 20 scientific employees who look after the assignments and functions of the Centre and also cater the needs of the stake holders in completing their projects of national importance within a stipulated time frame.

The Finance Committee in its meeting held on 15th March 2019 recommended the creation of the scientific posts. The FC also advised the Centre to submit the proposal to the UGC for further necessary approval alongwith detailed justifications for the Creation of Scientific/Technical Post.

After detailed discussions and deliberations, the Members endorsed the decision of the Finance Committee for creation of scientific positions as per the given details:

37.9 Creation of Administrative and Support area posts

The Members were briefed that Centre is having Nine Administrative staff which is very less manpower compare to its objectives to fulfil assignments and functions that Centre has taken up. The Members were also briefed that the INFLIBNET Program was established in 1991 as a project under IUCAA, Pune and in May'1996 the Centre was formed as an Inter University Centre of the University Grants Commission. At that time it had an approximate budget of Rs 3 crores and now it has a budget approximate of Rs.360.00 Crores that has increased more than 100 times accordingly



and

all other administrative works have increased but the number of Administrative employees remained same.

The Director of the Centre also projected the need of creation of separate Finance section and other administrative staff for smooth functioning for the Centre. It was also briefed that earlier the Centre had Two Administrative Officer one for each Administration with Store & Purchase and another for Finance and Accounts till December, 2010 including one Sr. Administrative Officer till September 2011.

The Finance Committee in its meeting held on 15th March 2019 recommended the creation of the Administrative positions and creation of Finance section. The FC also advised the Centre to submit the proposal to the UGC for further necessary approval along with detailed justifications.

The Governing Board felt the requirement of more administrative positions to Co-op up multi fold increased activities of the Centre and also opined to have separate Finance section for smooth functioning and to maintain checks and balance. The Members endorsed the decision of the Finance Committee for creation of Administrative positions as per the following details. The Finance Committee also advised the Centre to hire the MTS/helpers on contractual basis through manpower agency as per requirements rather than asking for creation of such posts.
