The 20th Meeting of the Council, INFLIBNET Centre commenced with the welcome of Prof D P Singh Jee, President, Council, INFLIBNET Centre & Hon'ble Chairman, UGC and other Members of the Council by Prof J P Singh Joorel, Director, INFLIBNET Centre. He also introduced the new Members of the Council.

Prof D P Singh. President, Council of the INFLIBNET Centre & Hon'ble Chairman, UGC extended a warm welcome to all the Members of the Governing Council and appreciated the outgoing Members of the Council for their continuous guidance, support in the overall development of the INFLIBNET Centre.

20.1 Presentation on the new and ongoing Projects/Activities undertaken by the Centre

Prof Joorel, Director, INFLIBNET Centre made a brief presentation on the various activities undertaken by the Centre especially during COVID-19 for the benefits of students and teachers. The Members appreciated the INFLIBNET Centre for initiating the activities which directly link with imparting teaching and disseminating e-contents and other resources.

a. YUKTI: A web-portal YUKTI (Young India Combating COVID with Knowledge, Technology and Innovation) is a unique portal and dashboard to monitor and record the efforts and initiatives of MHRD. The portal intends to cover the different dimension of COVID-19 challenges in a very holistic and comprehensive way. The portal was developed for MHRD and it was launched by Hon'ble Human Resource Minister Shri Ramesh Pokhriyal "Nishank".

- b. ILMS: Due to the Covid-19, the teachers and students are suffering the routine academic activities, so the INFLIBNET Centre, under the guidance of the UGC has taken initiative to provide Customized Learning Management System to Universities. The special feature of this platform is its pre-loaded courses i.e. it provides pre-populated learning content of PG courses which was developed under e-PG Pathshala (one of the flagship e-content projects of UGC-MHRD) as per the prevailing guidelines of UGC. The Centre is using open source learning management software (Moodle).
- c. One India One Digital Platform: The INFLIBNET Centre has taken an initiative to make available all the resources being developed under NME-ICT, MHRD through a single web interface. As an outcome "One India One Digital Platform" is conceptualized under the guidance and support from UGC and MHRD. The INFLIBNET Centre has developed an integrated e-Content portal. The "One India One Digital Platform" isan integrated e-Content portal which provides facility to search and browse all hosted content or metadata of other hosted content wherein a learner can easily access the desired material including audio/video learning material, textual material, multimedia enriched materials etc. It is made for learners of Class I to PG level.
- d. INFLIBNET Access Management Federation (INFED): As we know that the students and faculty members are away from their respective universities & Institutions and are being deprived for access of the subscribed e-resources. Thus Inflibnet centre took a lead in resolving this problem and INFLIBNET Access Management Federation (INFED), the first and only Federation in India, which is providing authorized users from colleges and universities to get seamless access to their subscribed e-resources from anywhere, anytime, his/her campus, home or even while travelling. INFLIBNET Access Management Federation (INFED) is based on Shibboleth, an open source software, which is among the world's most widely deployed federated identity solutions, connecting users to applications both within and between organizations. The INFLIBNET Centre is offering this service and it's an ongoing project. During the lockdown period, Inflibnet Centre has created this facility for many Universities/CFTIs and work for more universities is in process.
- e. Online Trainings: The Inflibnet Centre has taken a lead in providing/conducting online training programmes for LIS professionals, faculty members and students in collaboration with different Universities/Institutions/ Colleges/Associations.

The Hon'ble President requested the Members of the Council to opine on activities carried out, work and performance of Centre.

The Members opined that INFLIBNET may evolve a strategy so that students and teachers are made aware of the various resources provided for the educational community. The Members opined that the INFLIBNET is doing wonderful work in the field of digitisation and shall continue the same for the benefit of the educational community. It was opined that the students, teachers, research scholars may be facilitated with the remote/off campus access to the resource material for study.

The Members also discussed about the need of online courses in various Indian languages and Prof A D Sahasrabudhe, Chairperson, All India Council of Technical Education, briefed the Members that the efforts are being made to translate the SWAYAM and SWAYAMPRABHA courses in eight Indian languages. It was also discussed that the benefit of the resources shall reach to the grass root level in colleges and schools.
